June also brings the annual dues notice for your membership with the West Battle Lake Lakeshore Association. This notice got me thinking about the duties of the Lake Association and some of the benefits of being a member. Through your annual dues, you support the important activities undertaken by the association that will help to preserve and enhance the ecology of West Battle Lake so that it may be enjoyed by current and future generations. Here are a few of the duties of the Lake Association and why I feel it is important to be a member of the West Battle Lake Lakeshore Association (WBLLA):

Water Quality. To measure and help control pollution, and study ways to protect the environment and natural resources.

Water Clarity. To check the clarity of West Battle Lake with regular Secchi Disc readings.

Invasive Species Prevention. To operate programs that help to protect West Battle Lake from infestation of Aquatic Invasive Species (AIS).

Distribute Information to Members. To publish and distribute newsletters to members, and keep the public informed about key issues affecting the West Battle Lake area.

As we approach the **August 1**, **2015 deadline** for acceptance of Nominations for Volunteer and Lake Association of the year, we ask that you honor your volunteers who tirelessly share their time and talent, either individually or as a group.

The OTC COLA's Volunteer of the Year and Lake Association of the Year is about inspiring, recognizing and encouraging volunteers to assist in protecting and preserving the lakes they love. Self-nominations are accepted.

Do not pass up this opportunity to inspire, recognize, encourage and engage your volunteers who have demonstrated that they have the fortitude to meet challenges and accomplish goals.

Volunteer of the Year Nominee Criteria:

Can be a past or present volunteer; and Has made a significant investment of their time and talent to protect and preserve their lake; or

Has demonstrated an ability to bring people together and engage them in activities that protect and preserve the lake; or

Has demonstrated an ability to bring about positive change.

The Lake Association of the Year Nominee Criteria:

Must be a present member of the OTC COLA; and Successfully implemented a lake improvement project; Successfully or implemented an educational or outreach program; or Has substantially increased membership or participation of members; or successfully Has partnered with the local/county/state or federal government or agencies.

In no more than two (2) pages, describe the nominee's specific achievement (s). "Train the Teachers to Train the Kids" Jerry Horgen – Program Director

"Train the Teachers to Train the Kids" is a program funded by the Otter Tail County Commissioners and approved by the Otter Tail County Aquatic Invasive Task Force. The purpose of this program is to give accurate data on aquatic invasive species (AIS) to science teachers (in eleven school districts) in order that science teachers inform their kids and in turn "kids train other kids" on the prevention of aquatic invasive species-in a format that is unique to kids. A unique format, if you will, using perhaps some form of technology, then broadcasting the information to other students, in each school district, again, in a format that other kids will respond to-"kids training other kids."

Moriya Rufer, a biologist from RMB Labs in Detroit Lakes is the content expert in this program and Jerry Horgen is the program developer. Thus far, three workshops have been provided for science teachers whereby school districts have been given aquatic invasive species curriculum materials that meet Minnesota Curriculum Standards; provided aquatic invasive species kits to each school district and last fall provided two Aquatic Invasive Species Workshops on an infested lake to students from Underwood, Fergus Falls and Perham.

Beginning in January of this year, Moriya and I have given presentations to seven school districts-Battle Lake, Parkers Prairie, Ashby, Henning, Rothsay, Perham and New York Mills. Underwood, Fergus Falls and the Alternative School of Perham have participated in Outdoor Workshop on an infested lake in Otter Tail County last fall. This May 25-28th, we will be providing three Outdoor Workshops on an infested lake to school districts based upon the school's availability. We have a four hour cruise on a lake with 45 students per workshop and each student is tested on their knowledge of aquatic invasive species upon their completion of the Outdoor Workshop-due to MCA Testing issues from the state, we had Perham.

The key to this program is an aquatic invasive species contest whereby "kids train other kids" on aquatic species invasive issues. In this contest, which ends May 22, 2015, students in the eleven

school districts may submit a three minute video (You Tube/Vimeo) or another student friendly format that other kids will listen to and which spreads accurate information on aquatic invasive species from-"kids training other kids." Moriya Rufer and I will announce the winners May 29, 2015. The first prize winner will receive \$100 in cash and the science teacher will receive \$900 for classroom use on aquatic invasive species. The second prize winner will receive an AIS Fighter T-Shirt and \$200 to the school district for science materials. The winning video/unique idea will then be disseminated to other school districts and highlighted at an Otter Tail County Commissioners Meeting.

One final component of the program is to "hook up" lake associations with the science teachers to give science kids/students "real world projects" to do as extra credit and to bring in speakers into the classrooms, from the lake associations, to make "real" what is being taught...applies to their lake locally.
