Call to order

A brief meeting of the West Battle Lake Lakeshore Association Executive Board was held at Lion's Park in Battle Lake June 25th 2021 at 6:00 pm. Quorum Requirement

Discussion/Business Items

- 1. Tracy distributed an agenda for the annual meeting to be held the next morning.
- 2. Tracy distributed a Board member list showing who is up for re-election in 2021. This includes:

 - o Chad Schaefer (will extend term)

 - o Michael Rye (will retire from the board)
 - o Bonnie Werpy-Rye (will retire from the board)
- 3. Tracy updated the Board on the I-LID cameras which are now installed and operational.
- 4. Tracy showed the group the WBLA appreciation plaque she has had made to give to Jerry Horgen.
- 5. Tracy introduced our new Water Quality Tester, Steve Slatten. Steve indicated he was interested in joining the board.
- 6. Steve gave the Treasurer's report. There is currently \$60,509 in the general unrestricted account and \$25,402 in the restricted fish fund account. Steve anticipates that once all dues are counted around 315 of the 522 property owners will be paid members.
- 7. The group discussed the DNR's new Lake Management Plan for WBL. Specific action items agreed to are:
 - Request the DNR to drop the crappie limit from 10 to 5 and add a 10" minimum requirement.
 - Create a new checking account at First National Bank for the Fish Fund and deposit the \$25,402 from the current combined account into the new account.
 - Name the new account "West Battle Lake Lakeshore Association Walleye Fund"
 - Ask the bank to assist us in creating a vehicle where donations could be made to the fund electronically or via check.
 - Begin promoting the new fund to members and non members who may fish WBL.
 - Begin annual supplementing of the DNR's fall fingerling stocking with fingerlings (possibly yearlings if available) purchasedd using money from the Walleye Fund.
